Discussion was opened to the body on this proposal. Discussion began with Patrick Watkins wanting to look into the possibility of separating the event into Middle School and High school. Discussion was continued by Andy Escimillia, Jonathan Chesson, David Deese, Jason Childers, Mary Choat, Aaron Poteat. Matt Liner informed the body if there was a decision to change the clinic event there would need to be an update to the operation procedures and approved by the membership 1 year in advance. Operation procedures can be changed by the board. Matt Liner reminded the membership there was a motion on the floor and reread the board proposal. Jonathan Chesson made a motion to vote, Adam Joiner seconded the motion and Chad Higdon made a call to question. The body voted 37- FOR, 22- AGAINST, and 4 abstained. The board proposal passes and the clinic will be at Lenoir Rhyne University February 16-18.
